Europayment – refers to a payment order that is made-out in the EUR currency and then routed to the EEA using the SHA charging method and the NORMAL payment rate, with an account number in the IBAN format and the BIC of the payee's transferring institution.

SHA - the payer pays the fees of his/her bank, the payee pays the fees of his/her bank and also, where applicable, the fees of any other intermediary banks.

BEN - the payee pays all the fees, i.e. the fees of his/her bank, the payer's fees and where applicable, also the fees of any other intermediary banks.

OUR - the payer pays all the fees, i.e. the fees of his/her bank, the fees of the payee's bank and, where applicable, also the fees of any other intermediary banks. The costs of the other banks depend on the fees of the intermediary banks and the payee's bank. For payments in USD the fee type OUR can be changed by the corresponding foreign bank to the SHA type or BEN type, therefore the recipient can receive a lower amount.

URGENT - funds are credited to the recipient's bank account on the day of the order's maturity date. Urgent payments can only be made in EUR, USD, GBP and CAD. Urgent payment orders can be entered via PB channels on a business day until 1:00 p.m.

PRIORITY PAYMENT - payment orders for a non-cash domestic payment with a due date identical to the current calendar date and also a priority type of payment can be entered via the PB channels until 1:00 p.m. on a business day. An order of this kind will be cleared and sent to CERTIS on the same business day.
