Introduct Word

Dear shareholders, business partners and colleagues,

Let me briefly summarise the past year 2022, touching on the most important milestones through which Citfin has passed and mentioning those that lie ahead.

First, a few words on the economy. The domestic currency has gone through a very turbulent year. In the first quarter, shortly after Russia's invasion of Ukraine, it plummeted, falling as low as EUR/CZK 25.90. In contrast, the end of the year was marked by appreciation and saw the koruna below EUR/CZK 24.20. Its appreciation went hand in hand with the CNB's determination to raise rates. The base two-week REPO rate has gradually climbed to the current 7%, to where it was last raised by the Bank Board while still under the leadership of Jiří Rusnok. Rusnok was replaced by Aleš Michl as CNB governor in mid-2022, along with other central bankers. This basically meant a change in the majority of the Board, which has kept the main interest rate at the same level since then.

The domestic economy has started to show clear signs of slowing. The unemployment rate is going up slightly, but given the overheated labour market in recent years, some cooling may provide an interesting opportunity for most companies. We have noticed how consumers have begun to cut back on their spending, rationalising it substantially. Thus, households in particular and the most vulnerable groups such as single mothers and pensioners are certainly most concerned about the overall economic situation. Their moderation behaviour is quite understandable, although it has a negative impact on retail sales.

A wave of price increases has swept across the world, including the Czech Republic. Even though inflation had climbed to over 17% by the end of 2022, the next few months are promising in terms of some improvement. Although the Czech economy entered a recession in 4Q 2022, I believe, like most of us, that the Czech economy is stable and strong, able to go through this downturn quickly and start growing briskly again.

Unfortunately, literally all events and economic results have been fundamentally affected by Russia's unprecedented attack on Ukraine in February 2022. Price shocks resulting from the war were quick and crushing. The biggest impact was in fuel and energy prices. Indirectly, these impacts hit other products and services, then consumers themselves and, of course, every entrepreneur and company.



In the area of the balance sheet total, we approached CZK 3.92 billion. The capital adequacy ratio for Citfin, spořitelní družstvo reached a significantly safe level of 39.53% and for Citfin – Finanční trhy, a.s. it was 330.10%. I would like to emphasise here that the capital adequacy ratio of both companies is sound and is fully in line with the regulatory requirements set by CNB. The economic results continue to help us with all the investments that are most crucial for Citfin's future development.

At Citfin, 2022 has proven, among other things, that we can be an attractive and reliable employer. Our overall staff turnover rate was 0.9% and the average employment relationship extended to more than 7 years. Personally, I consider the stability of our team to be a key factor of professionalism and experience, which is a major added value for our clients.

It is also the reason why Citfin is able to work on itself and take its services to a higher level. We are investing heavily in strengthening our infrastructure, modernising it and increasing its efficiency. This year, Citfin is switching to new technologies in the areas of telephone and customer service, internet banking and its new Client API follow-up service. Along with these quite challenging projects, this year we will be launching a technologically advanced and new way of arranging contract documentation, gradually enabling each new client to arrange everything they need to work with us from the comfort of their office or home.

We will be actively communicating all the news and service expansions throughout the year, and I firmly believe that we will be able to introduce all the planned projects gradually and successfully.

Thank you for your goodwill so far, and let's all hope that we can overcome all challenges freely, in good health and above all with a smile.

A number of existing clients, as well as our new clients, have started to use our Exchange Rate Monitoring service via SMS. This is a logical consequence of the koruna's movement. Experience has clearly shown that small and medium-sized entrepreneurs, companies, multi-national corporations, as well as small business owners do not have time to constantly monitor the markets nowadays and leave this activity to professionals. Citfin has always

prided itself on quality individual care for its clients and will continue to do so in the future. We take care of all companies and business owners who have made the decision to be with Citfin and provide them with updated information on the foreign exchange market in various forms and channels throughout the day. Our news and economic portal www.edevizy.czhas also scored a great success. In just a few months, more than 35,000 unique users have read our news and comments, as well as interesting articles on current topics.

We will continue to work on improving our products and services in the coming period. One of the planned goals is to simplify the process of acquiring a new client through online onboarding, which aims to streamline the process of signing the contractual documentation needed to establish mutual cooperation.

In conclusion, let me first of all thank all our clients for their goodwill and our great staff for their proactive and professional approach with which they take on all challenges. And finally, thank you to all our business partners for their support and great work. I wish everyone great success in their personal and professional lives and hope that we will continue to meet together in 2023.

The number of foreign payment transactions executed in thousands




The number of domestic payment transactions executed in thousands




